**Refund Rules:** The Schedule of refund of fees will be as follows as per UGC rule December 2016:

If a student chooses to withdraw from the program of study in which he / she is enrolled, the institution concerned shall follow the following four-tier system for the refund of fees remitted by the student.

Sr. No.	Percentage of Refund of Aggregate fees*	Point of time when notice of withdrawal of admission is served to HEI
(1)	100%	15 days before the formally-notified last date of admission (on or before 9 <sup>th</sup> July 2018)
(2)	80%	Not more than 15 days after the formally-notified last date of admission (from 10 <sup>th</sup> July 2018 to 9 <sup>th</sup> August 2018)
(3)	50%	More than 15 days but less than 30 days after formally-notified last date of admission (10 <sup>th</sup> August 2018 to 24 <sup>th</sup> August 2018)
(4)	00%	More than 30 days after formally-notified last date of admission (from 25 <sup>th</sup> August 2018 onwards)

In case of (1) in the table above, the deduction will be 10% of the aggregate fees as processing charges from the refundable amount. Aggregate fees is inclusive of course fees and non-tuition fees but exclusive of caution money and security deposit.
