1 Introduction:

- **1.1** The Master of Physiotherapy course is a full-time program of 2 years (4 Semesters) leading to the degree that equips the student with analytical, evidence-based learning skills.
- **1.2** The different specialty courses as shown below for giving preferences are:
 - MPT- Musculoskeletal Sciences
 - MPT- Neurosciences
 - MPT- Cardio-Respiratory Sciences

1.3 Scope of the Course:

- Focuses on gaining advance understanding, knowledge and exclusive skills in the specialized area.
- Enables in depth clinical reasoning, update students with recent advances in professional practice and ability to carry out a comprehensive, logical, safe, subjective and physical examination.
- Provides opportunities to work as a consultant, expert clinician in any tertiary set up and as a teaching faculty in Physiotherapy colleges in India and Abroad.

2 Eligibility Criteria:

- Minimum 50% aggregate marks in the Bachelor's Degree (10+2+4years+6months of internship) in Physiotherapy from UGC recognized institutions.
- Done Internship program of 6 months from a college or University recognized by Indian Association of Physiotherapists (IAP) and completed before or on 31st July 2024.
- Membership of Indian Association of Physiotherapists (IAP)

Note:

- Candidates undergoing the internship may also apply; provided their internship is completed before the commencement of the course. i.e. by 31st July 2024.
- II. Those candidates who have passed from a University where Grade Point Average is given, such candidates must produce in writing from the University concerned about the equivalent percentage for the GPA / CGPA obtained.

- III.Submission of AIU equivalence certificate to confirm the eligibility for the program is mandatory for
those candidates who have completed their Under-Graduation from overseas board/ Universities.
- **3 Duration:** Two years
- 4 Intake: will be notified at the time of admission process.

5 Online registration & Payment of registration fee:

5.1 Online registration:

5.2 Payment of registration fee:

- Online Registration Fee of Rs. 2,500/- plus GST if applicable (Please refer online registration for payment details)
- Registration Fee is **NON-REFUNDABLE / NON-TRANSFERABLE**.

List of Documents:

- All years Bachelor's Degree Mark sheets & Degree Certificate for passed candidate (attested photocopy)
- Indian Association of Physiotherapists (IAP) membership certificate (attested photocopy)
- 6 months Internship Certificate (attested photocopy)

Candidate's application form will not be considered if they fail to upload the above mentioned document till last date of online registration.

6 Selection Process:

Entrance Test (50 Marks) followed by Personal Interview (50 Marks)

A. Entrance Test

- Syllabus- coursework of four years of Bachelors of Physiotherapy
- Total Marks- 50
- Duration one hour
- All questions are compulsory & in multiple choice format

B. Personal Interview

• Total marks- 50

- Personal Interview may include a 5 minutes presentation by the candidate on their Internship project or demonstrations of evaluation and treatment.
- Admission offer is given as per merit and vacancy. Selected Candidate has to confirm his / her provisional admission by filling up e-admission form, uploading required document and paying fees within given timeline. Kindly note that only those candidates who complete the process by paying fees will be admitted to the program.
- WAITLISTED candidates have to check their merit list status as per date given on the website.
- Merit list will be based on written test & Personal Interview score

7 **Program Fees:**

Fees for 1st year (Batch-2023) was: Rs. 3,50,000/- (for information only). Fees for 1st year (Batch-2024) will be declared at the time of admission.

8 **Refund Rules:** If a student chooses to withdraw from the program of study in which he / she is enrolled, the institution shall follow the following five-tier system for the refund of fees remitted by the student.

Sr. No.	Percentage of Refund of Fees	Point of time when notice of withdrawal of admission is received in the Higher Educational Institutions (HEI)
(1)	100%	15 days or more before the formally-notified last date of admission
(2)	90%	Less than 15 days before the formally-notified last date of admission
(3)	80%	15 days or less after the formally-notified last date of admission
(4)	50%	30 days or less, but more than 15 days, after formally-notified last date of admission
(5)	00%	More than 30 days after formally-notified last date of admission

In case of (1) in the table above, the deduction will be 5% of the fees paid as processing charges from the refundable amount, subject to a maximum of Rs 5,000/-.

- Note: 1) The above refund rules are subject to revision as applicable
 - 2) Candidates to refer Important Dates of the respective programme & refer refund rules mentioned in the offer letter.

9 Important Instructions:

- Please see the important dates and preserve it as a guide. All announcements from the University
 will be through its website <u>www.nmims.edu</u> and there will be no separate mail sent. Kindly check
 website for regular updates.
- It is the sole responsibility of the candidates to ascertain whether they possess the necessary and requisite qualification for the admission to the courses at NMIMS.

- AIU certificate is mandatory for those candidates who have completed their Graduation / Postgraduation from overseas Universities.
- Canvassing in any form will disqualify the candidate
- If at any stage, it is found that a candidate does not satisfy the eligibility criteria or the information furnished by him/her is incorrect, than application for the admission to the Program, even if selected and fees paid, will stand cancelled and fees will be refunded as per NMIMS refund policy.
- Admission for appearing Candidates will be provisional till submission of Final Marksheet and will be confirmed on submission & if found eligible as per eligibility criteria.
- Candidate's documents will be verified at the time of admission (if selected) & if found not eligible, admission will be cancelled and fees will be refunded as per NMIMS refund policy.
- For cancellation/ withdrawal of admission: Withdrawal / cancellation means voluntary withdrawal / cancellation by candidate for any reason. Candidate has to upload cancellation form duly filled and signed; fees paid receipt copy & cancelled cheque (personal account) to mentioned link: https://upload.nmims.edu/admission/cancellation/
- NMIMS has full right to disqualify a candidate at any stage of admission process if found ineligible.
 No separate intimation will be given in this regard.
