**Refund Rules:** If a student chooses to withdraw from the program of study in which he / she is enrolled, the institution shall follow the following five-tier system for the refund of fees\* remitted by the student.

Sr. No.	Percentage of Refund of Fees*	Point of time when notice of withdrawal of admission is received in the Higher Educational Institutions (HEI)
(1)	100%	15 days or more <b>before</b> the formally-notified last date of admission ( <b>on or before 5<sup>th</sup> August 2019</b> )
(2)	90%	Less than 15 days <b>before</b> the formally-notified last date of admission ( <b>6<sup>th</sup> August 2019 to 21<sup>st</sup> August 2019</b> )
(3)	80%	15 days or less <b>after</b> the formally-notified last date of admission ( <b>22<sup>nd</sup> August 2019 to 5<sup>th</sup> September 2019</b> )
(4)	50%	30 days or less, but more than 15 days, <b>after</b> formally-notified last date of admission ( <b>6<sup>th</sup> September 2019 to 20<sup>th</sup> September 2019</b> )
(5)	00%	More than 30 days <b>after</b> formally-notified last date of admission ( <b>21<sup>st</sup> September 2019 onwards</b> )

**\*For Payment of Fees Sundays and Holidays Excluded**

In case of (1) in the table above, the HEI concerned shall deduct an amount not more than 5% of the fees paid by the student, subject to a maximum of Rs. 5,000/- as processing charges from the refundable amount.

The above refund rules are as per University Grants Commission (UGC) notification on Refund of Fees and Non-Retention of Original Certificates of October, 2018 and are subject to revision as per UGC notification (as applicable). Please note the closure of admission/last date of admission as mentioned in the refund is Wednesday, 21<sup>st</sup> August, 2019.
