<u>Refund Rules</u>: If a student chooses to withdraw from the program of study in which he / she is enrolled, the institution shall follow the following five-tier system for the refund of fees* remitted by the student.

Sr. No.	Percentage of Refund of Fees*	Point of time when notice of withdrawal of admission is received in the Higher Educational Institutions (HEI)
(1)	100%	15 days or more before the formally-notified last date of admission (on or before 5 th August 2019)
(2)	90%	Less than 15 days before the formally-notified last date of admission (6 th August 2019 to 21 st August 2019)
(3)	80%	15 days or less after the formally-notified last date of admission (22nd August 2019 to 5th September 2019)
(4)	50%	30 days or less, but more than 15 days, after formally-notified last date of admission (6 th September 2019 to 20 th September 2019)
(5)	00%	More than 30 days after formally-notified last date of admission (21 st September 2019 onwards)

*For Payment of Fees Sundays and Holidays Excluded

In case of (1) in the table above, the HEI concerned shall deduct an amount not more than 5% of the fees paid by the student, subject to a maximum of Rs. 5,000/- as processing charges from the refundable amount.
