4.	Conduct of Written test (Timing 11:00 am to 12:00 noon)	Saturday, 22 <sup>nd</sup> July 2023
5.	Conduct of Personal Interview (2 pm onwards)	Saturday, 22 <sup>nd</sup> July 2023
6.	Result – Declaration of Merit List (after 5.00 p.m.) candidate need to check from their dashboard.	Friday, 28 <sup>th</sup> July 2023

**Refund Rules:** If a student chooses to withdraw from the program of study in which he / she is enrolled, the institution concerned shall follow the following five-tier system for the refund of fees remitted by the student.

Sr. No.	Percentage of Refund of Aggregate fees	Point of time when notice of withdrawal of admission is served to HEI
(1)	100%	15 days or more <b>before</b> the formally-notified last date of admission.
(2)	90%	Less than 15 days <b>before</b> the formally-notified last date of admission.
(3)	80%	15 days or less <b>after</b> the formally notified last date of admission.
(4)	50%	30 days or less, but more than 15 days, <b>after</b> formally notified last date of admission.
(5)	00%	More than 30 days <b>after</b> formally notified last date of admission.

In case of (1) in the table above, the HEI concerned shall deduct an amount not more than 5% of the fees paid by the student, subject to a maximum of Rs. 5,000/- as processing charges from the refundable amount.
